ALA upholds its support for LGBTQIA+ library workers and reaffirms its commitment to equity and inclusivity

Following deep consideration of feedback from members and volunteers around the world, the International Federation of Library Associations and Institutions (IFLA) Governing Board 2021-23 reaffirms its decision to hold the 2024 World Library and Information Congress in Dubai.

It acknowledged concerns about the legal framework of LGBTQ+ rights in the United Arab Emirates as well as the ability of all IFLA units to organise sessions-and that the LGBTQ+ community in particular may feel unwelcome because of the exclusion of specifically-themed LGBTQ+ topics from the WLIC programme. It nonetheless noted that a conference in Dubai would offer many colleagues who may otherwise never be able to participate in a single WLIC, for economic or visa reasons, a chance to do so.

<u>Council passed a resolution</u> at Annual regarding IFLA's siting of the conference in Dubai. The topic will be on the agenda for our January meetings at LibLearnX
