

New Jersey's Libraries = Education

Libraries are essential providers of education for New Jersey residents of all ages. Ensuring that the people of New Jersey have access to strong, relevant library services in their community requires a funding partnership between local libraries, communities and the state of New Jersey.

The American public values library services. A recent Pew Research survey found that 94% of Americans say public libraries improve the quality of life in a community.

Restore Funding for the State Per Capita Aid program.

The State Per Capita Library Aid program is a direct partnership between local libraries and the state. State Aid is awarded to municipalities for library purposes based on local funding and meeting state standards for library service. This is direct aid to every local library. Current funding has been reduced to \$3,676,000 beginning with the FY11 state budget. That is approximately 41 cents per person per year as the state's contribution to public libraries and lifelong education. Since FY11, the state budget has increased from \$28.4 billion to \$34 billion in 2016. Many programs which had suffered funding cuts in the FY11 budget have been restored. Funding for library services, unfortunately, has remained at this decreased level despite advocacy efforts by the New Jersey Library Association Per Capita support is currently less than the cost of a postage stamp.

To fulfill the commitment of the state to the state per capita aid program we seek an additional \$ 5.5 million dollars. This would ensure that every library that meets minimum state library service standards would receive at least \$1.00 per capita under the state per capita aid program.

In this legislative session, bills were re-introduced (**S430 and A2227**) to increase the state per capita aid program by \$3 million. These bills sponsored by Senator Diane Allen in the Senate and Assemblyman Troy Singleton in the Assembly. Last session, these bills had exceptional bi-partisan support with 43 members of the Legislature signed on as co-sponsors. NJLA is grateful to the legislators who sponsored this legislation and supports all legislative initiatives to help us reach our goal of an increase of \$5.5 million for state per capita aid.

Establish a Capital Construction Program for Public Libraries

A222 "New Jersey Library Construction Bond Act" authorizes the issuance of 125,000,000 of general obligation bonds to finance capital projects in public libraries. This bill is sponsored by Assemblyman Wayne DeAngelo (District 14) with seven co-sponsors in the Assembly. If enacted the bill would permit a public referendum to be placed on the ballot at a general election asking the public if they would approve the state bonding for library capital needs.

- A survey conducted by NJLA in Sept. 2014 demonstrated the strong need for capital funding for physical and technological improvements in public libraries to meet the growing demands of new technology, increased library usage including e-government demands and ADA requirements.
- The last program for capital construction in public libraries was passed approximately 15 years ago with a \$ 45 million bond act. With this funding sixty-eight library projects were completed.

Public libraries are community cornerstones in providing lifelong education, from pre-schoolers to senior citizens offering a wide variety of classes and services – including information, literacy, technology and training.

Uphold Strong Local Support for Public Libraries.

Nearly 98% of public library funding support is from the local community. Library resources provide vital educational and economic opportunities for the residents of New Jersey. Strong library services are a critical factor in supporting quality of life and the economic vitality of our state.

- Municipal public library tax funding is set at the minimum 1/3 mil level. It accounts for approximately 2% of a property owner's total tax bill or \$33 of support on a home with a \$100,000 equalized assessment.
- The economic downturn of the past several years has had a direct impact on local library funding.
 Decreased property values in New Jersey have automatically reduced the local Library tax funding significantly since 2006.

A1427 would permit increases in the municipal free public library tax rate above the current 1/3 mil upon voter approval. This bill is sponsored by Assemblyman Gordon Johnson (District 37) and has also been referred to the Assembly State and Local Government Committee.

NJLA will oppose any efforts to weaken the current state minimum one-third mil funding floor for municipal libraries.

Support Funding for the New Jersey Library Network.

The New Jersey Library Network provides cost-sharing opportunities which provide financial savings for all types of libraries. It is fundamentally important for local libraries to expand services to residents through the availability of a statewide library delivery system and through resource sharing agreements. Since its inception, this extraordinarily successful program has resulted in the savings of millions of dollars for local libraries.
